Peoria Area Safety and Risk Management Seminar Recap



On March 22, FCA of Illinois in partnership with the Greater Peoria Suppliers and Contractors Association (GPCSA) hosted the Peoria Safety & Risk Management Seminar at the Holiday Inn. We were very pleased with the turn out!

Updated for current safety issues, we worked hard to bring our members needed information on OSHA logs, insurance needs, mental health issues, drugs and alcohol testing, and what elements contribute to a good safety and risk management program.

Our FCAI Safety Committee consists of Charlie Vasconez - MSM Solutions, Tyler Stark - International Decorators, Brittany Selin - formerly of All-Tech Decorating, and Kevin Lefko - Lankford Painting Division.

Opening our Peoria Area seminar was Labor Associate Dan Birnbaum from Seyfarth Shaw, LLP who spoke to the participants about types of OSHA citations, how to manage an OSHA visit and how to reduce the risk of OSHA citations. Our Safety Committee then took the audience through the seven core elements of a complete safety program. Their years of experience and knowledge was well illustrated through the specific information and examples they shared with the audience. We are fortunate to have them speak about how their companies -large and small- deal with specific hazards and safety concerns to properly and safely manage workers.

Our next presenter was Roger Mohn from NAMI-Illinois who spoke to the group about mental health concerns and gave good information on what to do when someone is in crisis and where to get help.

Our next presentation was about what contractors should know about drugs, marijuana, and alcohol by Admunsen Davis labor attorney, Jeff Risch. Jeff told our audience the intricacies of drug testing - when to test, how often to test, and what to test for. He also addressed the basics of reasonable suspicion and how supervisors and leaders can legally manage suspicion. Finally, Devin Moore from Federated Insurance took the participants through current factors that affect contractor insurance rates and gave examples of how mod rates affect premiums. He also spoke about workman's compensation claims and took audience questions.
